説明

TPS62A204QEV-116 は、高効率かつ小型設計向けに最適化された、車載用同期降圧 (バック) コンバータの TPS62A20XQ ファミリー向けの評価基板です。

TPS62A204QEV-116 は、最大 4A の出力電流を供給します。この評価基板は、TPS62A20x-Q1 と TPS62A2Nx-Q1 シリーズに使用できます。

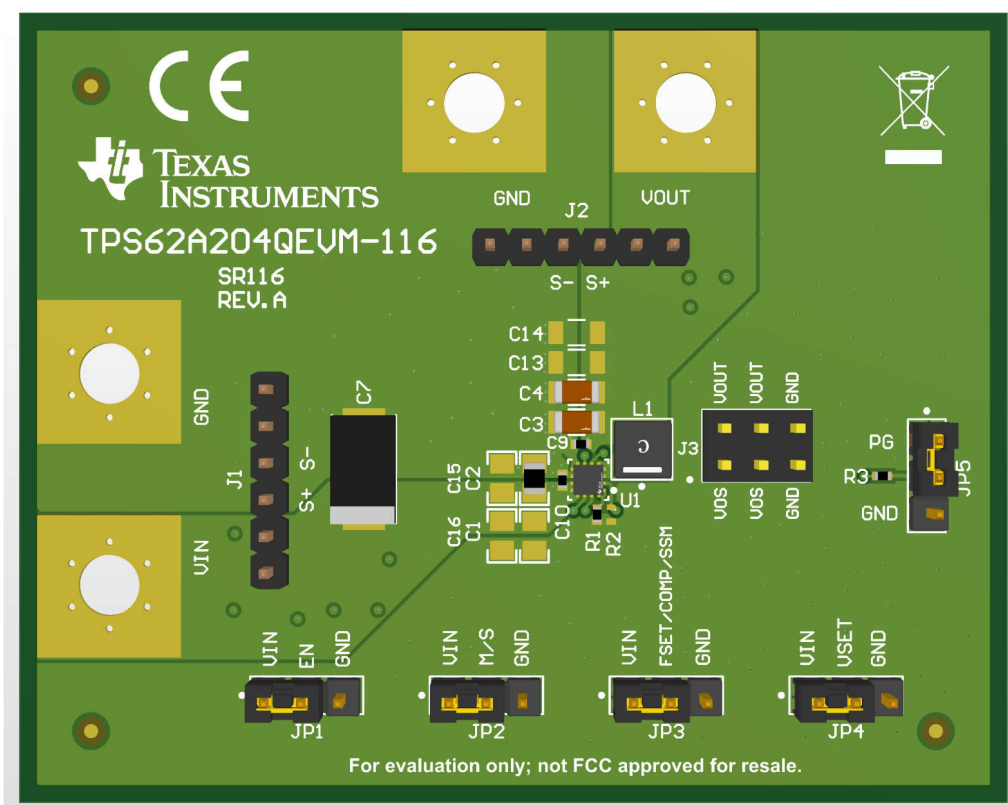

1 評価基板の概要

1.1 はじめに

この評価基板は、ユーザーが TPS62A20x-Q1 および TPS62A2Nx-Q1 シリーズの降圧コンバータの動作や機能を容易に評価、テストできる設計を採用しています。2.75V ~ 6V の入力電圧を 3.6V (JP4 を VIN に接続時) または 1.8V (JP4 を GND に接続時) の安定化出力電圧に変換し、最大 4A まで供給できます。このユーザー ガイドでは、IC TPS62A20x-Q1 および TPS62A2Nx-Q1 の特性、動作、および使用方法について説明します。このドキュメントには、以下のセットアップ手順が含まれています。

TPS62A204QEVM-116 の基板には、TPS62A204DQWRZXRQ1 IC が搭載されています。使用事例に応じて、基板上の IC を他の OPN に変更できます。

1.4 デバイス情報

この評価基板の PCB は、この IC の可変電圧バージョンに対応するよう設計されています。評価基板上では、VSET ピンに接続された抵抗を調整することで、目的の出力電圧を設定できます。他の入力コンデンサおよび出力コンデンサを追加することもできます。モードは、JP2 を VIN に接続すると FPWM に、GND に接続すると PFM に設定されます。本デバイスのスイッチング周波数は、CONF (FSET/COMP/SSM) ピンに接続された抵抗 R1 で調整できます。この評価基板では、CONF ピンは JP3 で VIN に接続されています。

2 ハードウェア

2.1 構成

このセクションでは、TPS62A204QEVMM-116 の適切な使用方法について説明します。

2.1.1 コネクタの説明

J1、ピン 1 および 2 – VIN	評価基板の入力電源からの正の入力電圧接続
J1、ピン 3 および 4 – S+/S–	入力電圧センス接続。このポイントの入力電圧を測定します
J1、ピン 5 および 6 – GND	評価基板の入力電源からの入力リターン接続
J2、ピン 1 および 2 – VOUT	正の出力電圧接続
J2、ピン 3 および 4 – S+/S–	出力電圧センス接続。このポイントで出力電圧を測定します
J2、ピン 5 および 6 – GND	出力リターン接続
JP2– M/S (Mode/Sync)	M/S ピンは、ジャンパで VIN に接続すると FPWM モードに、GND に接続すると PFM モードにできます。
JP1 - EN	EN ピン ジャンパ。VIN と EN の間に付属のジャンパを配置すると、IC をオンにします。GND と EN の間にジャンパを配置すると、IC がオフになります。
JP3 – FSET/COMP/SSM (CONF)	このピンは、必要な設定に応じて、VIN または GND に接続したり、抵抗を介して GND に接続することができます。CONF ピン構成オプションについては、 TPS62A20x-Q1 および TPS62A2Nx-Q1 (2.75V ~ 6V 入力、1A/2A/3A/4A 車載、高速過渡、同期整流降圧コンバータ) のデータシート をご参照ください。
JP5 – PG プルアップ電圧	PG ピン プルアップ電圧ジャンパ。付属のジャンパを JP5 に配置し、PG ピン プルアップ抵抗を出力電圧に接続します。また、ジャンパを取り外し、ピン 1 に別の電圧を供給することで、PG ピンを異なるレベルにプルアップできます。この外部印加電圧は 5.5V 未満である必要があります。

2.1.2 ハードウェア設定

この評価基板を動作させるには、[コネクタの説明](#)に従ってジャンパ JP1 を目的の位置に設定してください。入力電源を J1 に接続し、負荷を J2 に接続します。

2.2 変更点

この評価基板 (EVM) のプリント基板 (PCB) は、ユーザによる一部の変更に対応できるよう設計されています。出力電圧に応じて、他の入力コンデンサ、および出力コンデンサを追加できます。また、出力電圧は VSET ピンに接続された抵抗により変更できます。データシートでスタートアップ出力電圧の表を確認してください。

2.2.1 入力と出力の各コンデンサ

C1、C15、C16 は、追加の入力コンデンサとして提供されています。このコンデンサは適切な動作に必須ではありませんが、入力電圧リップルを低減するために使用できます。

C13 と C14 は、追加の出力コンデンサとして提供されています。これらのコンデンサは適切な動作に必須ではありませんが、出力電圧リップルの低減および負荷過渡応答の改善に使用できます。適切に動作させるためには、出力キャパシタンスを [TPS62A20x-Q1 および TPS62A2Nx-Q1 \(2.75V ~ 6V 入力、1A/2A/3A/4A 車載、高速過渡、同期整流降圧コンバータ\) のデータシート](#)に記載されている推奨範囲内にする必要があります。出力コンデンサの選択については、セクション 9.1.1.3 を確認してください。

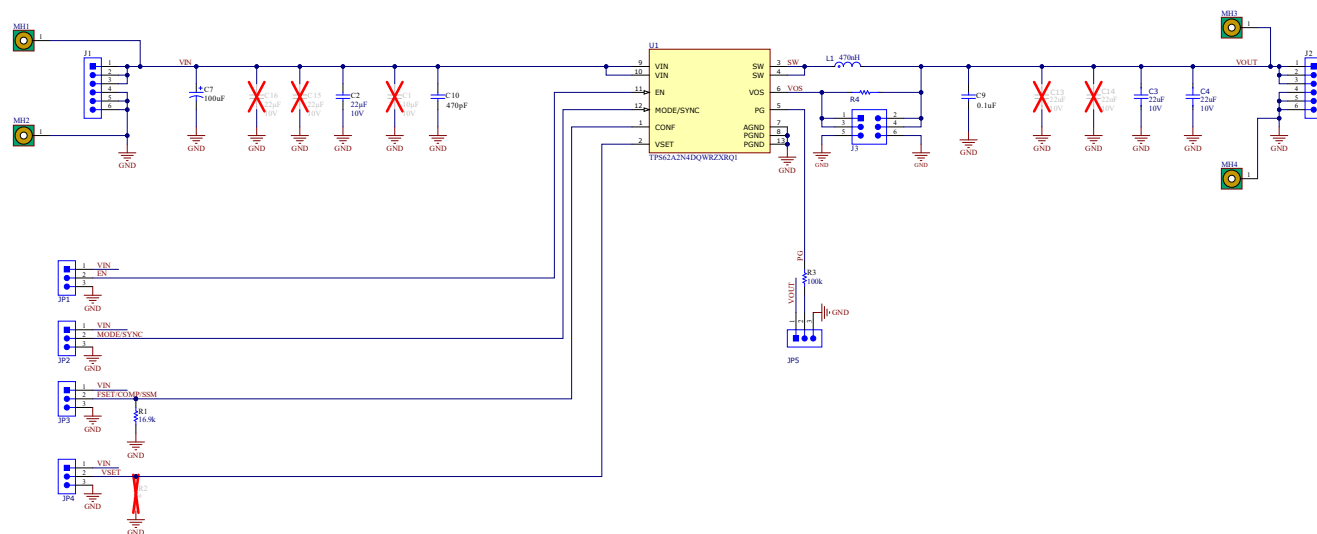


図 3-1. TPS62A204QEVM-116 の回路図

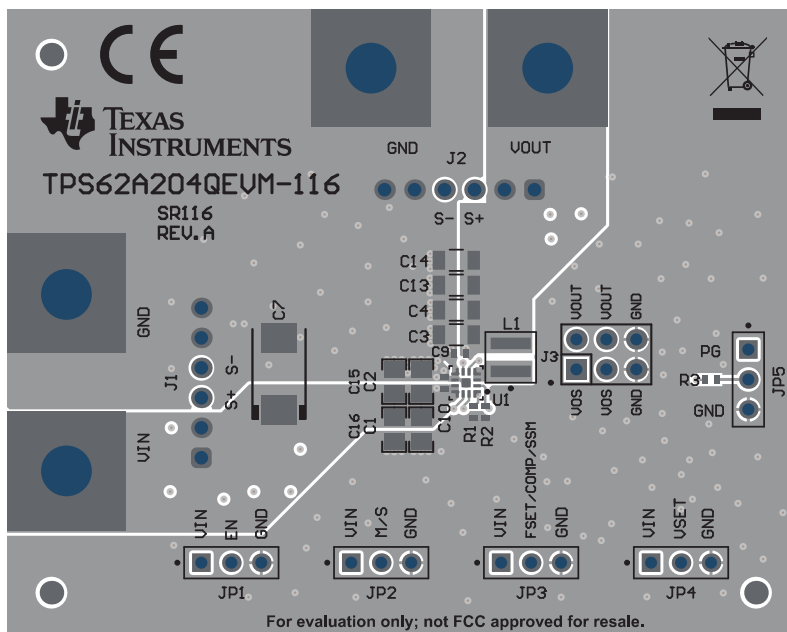


図 3-2. 上面図マスク

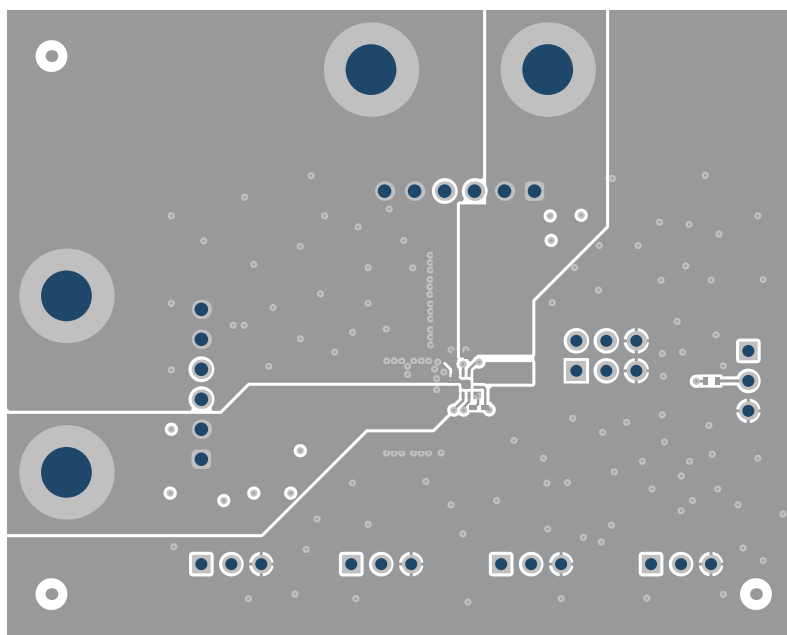


図 3-3. 上層

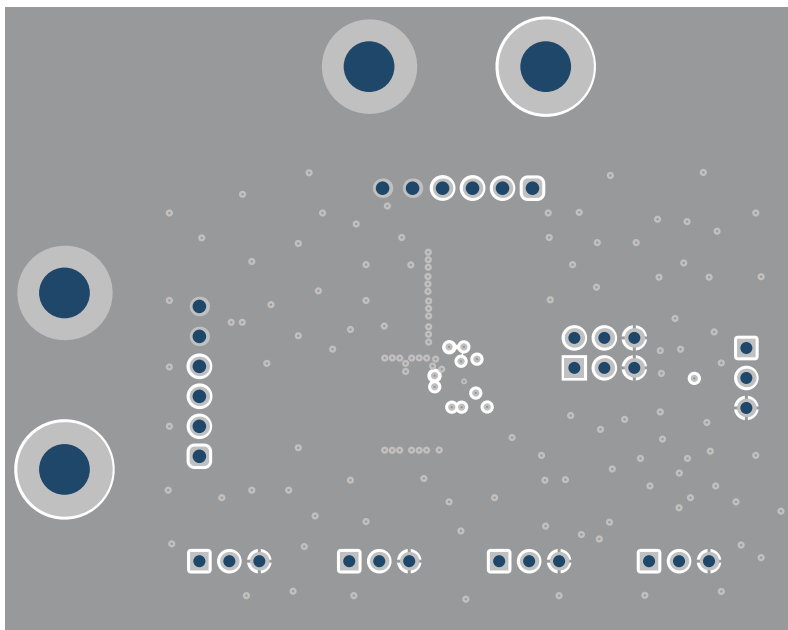


図 3-4. 信号層 1

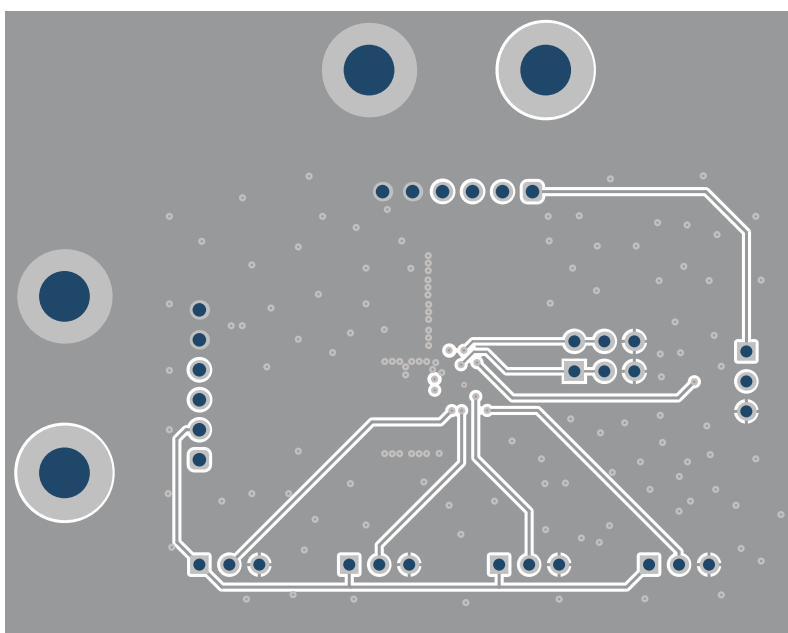


図 3-5. 信号層 2

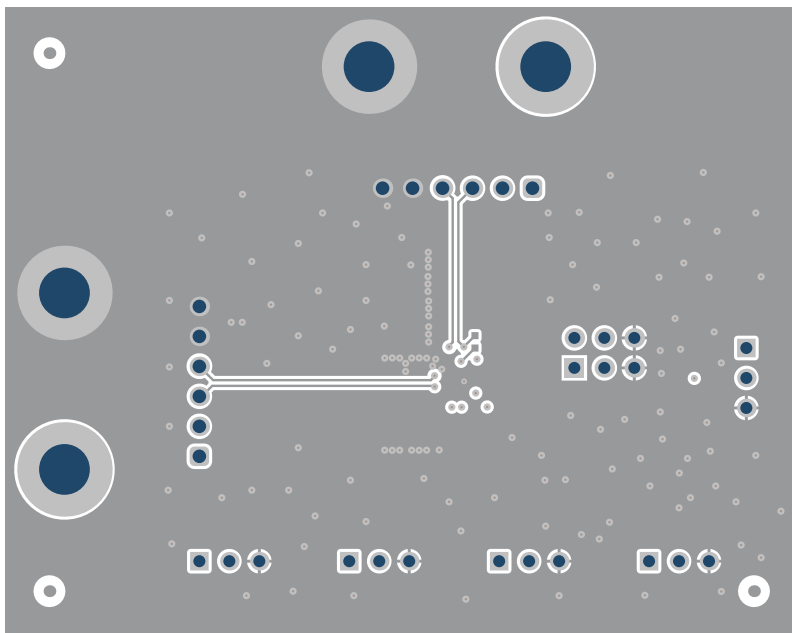


図 3-6. 下層
