DESCRIPTION/ORDERING INFORMATION

This quadruple 2-input positive-NAND gate is operational at 0.8-V to 2.7-V V_{CC} , but is designed specifically for 1.65-V to 1.95-V V_{CC} operation.

The SN74AUC00 devices perform the Boolean function $Y = \overline{A \cdot B}$ or $Y = \overline{A} + \overline{B}$ in positive logic.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.







PLASTIC QUAD FLATPACK - NO LEAD



PLASTIC QUAD FLATPACK - NO LEAD


